In the G.Os. first and second read above, orders have been issued transferring the assets, liabilities and staff of Andhra Pradesh Meat Development Corporation Limited to the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited, Hyderabad and to take action for closure of the Andhra Pradesh Meat Development Corporation Limited. In the letters third read above, the Director of Animal Husbandry has informed that the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited, Hyderabad in its 14th Board meeting has resolved to take the services of certain officers and staff of 10 Intensive Sheep Development Projects and other Farms relating to sheep and goat development from the administrative control of Animal Husbandry Department to strengthen the sheep and goat development activities and to promote the economic interest of the shepherd community in the State. He has requested the Government for transfer of the schemes relating to sheep and goat development from the administrative control of Animal Husbandry Department to the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited and to issue necessary orders for placing the services of such officers and staff under the control of and the schemes relating to sheep and goat development and funds along with related records the Managing Director, Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited.

2. After careful examination of the matter, Government hereby order for transfer the following schemes from the control of Director of Animal Husbandry Department to the administrative control of the Managing Director, Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited:

- i. Jeeva Kranthi Pathakam;
- ii. Supply of Breeding Rams & establishment of Market Yards under RKVY;
- iii. Sheep Insurance;
- iv. Bhed Palak Bhima Yojana (Central Wool Development Board); and
- v. NCDC Scheme on production and rearing of livestock by the District Sheep Breeders Cooperative Union, Kadapa.

3. The Government further order that the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited shall be for the entire State the implementing agency for implementation of schemes relating to sheep and goat development activities in the State.
4. Government also hereby order for placing the services of the officers and staff shown at Annexures I, II, III, IV and V from the control of Director of Animal Husbandry to the control of the Managing Director, Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited, Hyderabad on administrative basis, to strengthen the sheep and goat development activities and to promote the economic interest of the shepherd community in the State.
5. The officers and staff mentioned in the Annexures I, II, III, IV and V to this order shall continue to draw their salaries from the budget of Animal Husbandry Department as usual and shall work under the administrative control of Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited, Hyderabad.
6. All the existing farms in the State established for sheep and goat development shall be placed under the control of Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited, Hyderabad
7. The Director of Animal Husbandry shall take further necessary action accordingly.
