ORDER:

In the G.O. first read above, orders were issued constituting the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited with Principal Secretary to Government, Animal Husbandry, Dairy Development & Fisheries Department as Chairman and other official Members. In the G.O. second read above, orders are issued reconstituting the Andhra Pradesh Sheep and Goat Development Cooperative Federation Limited with Sri V. Gopinath, former MLA as Chairman and other official Members.

2. The Managing Director, Andhra Pradesh Meat Development Corporation Limited and the Member-Convenor of Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited in the letter fourth cited has informed that the three year term of Sri V. Gopinath as Chairman of Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited was expired on 17.5.2009 and at present, there is no Chairman or the Managing Director in the Federation. He has further reported that Government have requested him to furnish a draft Memorandum of Understanding for transfer of assets, liabilities and staff in favour of Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited. As per the registered Bye-laws of the Federation, only Managing Director of the Federation is authorized to sign the Memorandum of Understanding. In view of this, he has requested the Government to reconstitute the Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited with Special Chief Secretary to Government, Animal Husbandry, Dairy Development & Fisheries Department, Government of Andhra Pradesh as Chairman, as was done on previous occasions, so as to enable to appoint the Managing Director to the Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited for expediting the process of transfer of assets, liabilities and staff of the A.P. Meat Development Corporation to Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited.

3. After careful examination of the issue, Government hereby reconstitute the Andhra Pradesh Sheep & Goat Development Cooperative Federation Limited as follows with immediate effect:
